JUVENILES – State Law requires any person under 17 years of age to appear before the Judge. A parent or legal guardian must be present.

MINORS – (under age 21) Must appear in court if charged with a violation of the Alcohol Beverage Code.

If you wish to plead not guilty and set a trial date or if you wish to pay by mail, please enter a plea as indicated on reverse side and return it to the court on or before your court date. Refer to Fine Schedule for fine amount. Make payment by money order,

If you wish to enter a motion for a time payment plan, deferred adjudication or a driving safety course, you must appear in court at 10:00 a.m. on the court date which is noted on the bottom right-hand corner of your ticket, or complete the plea form below and mail it no later than your court date.
